The City Council of the City of Irondale, Alabama assembled in a public session at City Hall on March 20, 2018.

I. Invocation and Pledge

Mayor Moore gave the invocation and Councilmember Marino led the pledge of allegiance.

III. Approval of Minutes for the Pre-Council Meeting & the Regular Council Meeting for March 20, 2018

The minutes of the March 20, 2018, Pre Council Meeting and the Regular Council Meeting were distributed to each Councilmember and the presiding officer called for corrections. There were no corrections made to the Regular City Council Meeting Minutes, therefore it was moved by Councilmember Bearden and seconded that the minutes are approved without corrections.

The bills for \$86,732.13.28 were moved by Councilmember Spivey and seconded to be approved for payment; a copy of the list of invoices will be filed as an attachment to these minutes.

VI. Public Hearing

Notice is hereby given that at a regular public meeting beginning at 6:00 p.m. on Tuesday, April 3, 2018, in the Council Meeting Room at Irondale City Hall located at 101 20th Street South, Irondale, Alabama, the City Council of the City of Irondale (the "City") will hear comments from interested citizens concerning the proposed granting of certain economic incentives pursuant to a Project Development Funding and Cooperation Agreement, as amended ("PDFCA") by and between the City and 10 Below LLC d/b/a Simply 10 ("Developer") pursuant to Amendment No. 772 to the Constitution of Alabama of 1901 for the purpose of the City granting to Developer certain Economic Incentives (as defined in the PDFCA) related to the Project (as defined in the PDFCA) to be located in the City of Irondale, Alabama, which Project will promote the economic development of the City by inducing industrial and commercial enterprises to locate new facilities in the City.

The City proposes to pay the Developer on or before the fifth (5th) day following the end of each calendar quarter for the preceding quarter a sales tax rebate of one-half (1/2) of the total sales taxes paid to the City attributable to the gross sales generated by the Project until the first to occur of seven (7) years from the opening of the Project or the payment to Developer of \$97,884.00.

The public benefit sought to be achieved by the grant of the Incentives related to the Project is the promotion of the economic development of the City by inducing industrial and commercial enterprises to locate new facilities in the City (which would result in additional tax revenues for the City and additional jobs for the City's citizens). For purposes of Amendment No. 772 to the Constitution of Alabama of 1901, 10 Below, LLC d/b/a Simply 10 is the business entity for whose benefit the City proposes to lend its credit or grant public funds or things of value.

It was moved by Councilmember Marino and seconded to open the public hearing. There were no citizens who spoke in favor or opposition to this proposed economic incentive for 10 below LLC d/b/a Simply 10. It was moved by Councilmember Spivey and seconded to close the public hearing.
